Re: Action on Tokyo's Ivory Trade

Dear Governor Koike:

We applaud you and the Tokyo Metropolitan Government (TMG) for your leadership in taking strides to end Tokyo's role in the illegal ivory trade.

As communicated in our <u>May 2022 letter</u>, we welcomed the final <u>recommendations</u> released from the TMG designated Advisory Council on Regulation of Ivory Trade, an output resulting from the ivory trade assessment process you initiated in January 2020. We continue to urge the TMG to implement the recommendations of the Advisory Council to address concerns about Tokyo's ivory trade.

We were pleased to see the <u>letter you sent to three Ministers</u> of the national government, dated October 7, 2022, regarding ivory trade, especially the request that: "The national government should consider more effective measures as necessary, based on the situation of ivory trade and the moves of the international community". We acknowledge your statement that "local government's measures have limitations, so further efforts by the national government are indispensable", and concur that action within Tokyo is limited by the national government's position.

However, in November 2022 at the 19<sup>th</sup> meeting of the Conference of the Parties (CoP19) to the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES), the national Government of Japan (GoJ) explicitly <u>insisted that</u> its current ivory trade controls are sufficient and that its domestic ivory market is not contributing to illegal trade. At the meeting, many of Africa's elephant range states raised <u>concerns</u> that Japan's domestic ivory market is a source of ivory that is <u>exported illegally</u> to China and other countries, and thus is clearly contributing to illegal international trade in ivory. The GoJ did not acknowledge these concerns.

Under these circumstances, we believe that the international community's greatest hope for progress in Japan lies with the TMG, and yourself, for unilateral action from Tokyo. We reiterate that the Council's third recommendation has the most potential and needs further attention: "[...] **The Tokyo Metropolitan Government should consider legal or other effective means** to ensure that the ivory trade does not contribute to elephant poaching and illegal trade, while appreciating the cultural and artistic aspects of Japanese ivory products." (emphasis added)

We therefore urge Tokyo to continue to heed the recommendations from the Advisory Council and enact an ordinance adopted by the Tokyo Metropolitan Assembly to close the ivory market in Tokyo with only very narrow exemptions if necessary.

We also hope that the Tokyo Metropolitan Government will implement what the Advisory Council has recommended so that Tokyo can forge ahead with the international community in protecting elephants from the threats posed by ivory trade.

As always, we are sincerely grateful for your leadership and commitment to ensuring Tokyo does not contribute to the downfall of Africa's elephants and we stand ready to assist in whatever way we can.
